


Lockdown and emergency measures in Europe – current state of play (Update 21/01/2021)

Notes:

- In general, distances of 1.5 metres must be kept as part of physical distance measures. This document only specifies where there are different national requirements.
- In general, masks must be worn in closed public spaces. This document only specifies additional or lesser national requirements.
- Figures for infection rates over the past 14 days per 100.000 inhabitants in countries covered by this document were gathered on 20 and 21 January 2021.
- Nightlife establishments are as a general rule closed across Europe, unless specified otherwise.

<p>Austria</p> <p>New daily cases (national)</p> <p>1634.0 (19-01-2021)</p> <p>The daily increase of the cumulative positive cases to the Coronavirus infection. (source: JRC ECML)</p>  <p>(06-03-2020 - 19-01-2021)</p>	<p>Infection rate (cumulated past 14 days): 278.68 cases per 100.000 inhabitants (<i>down from 327.27 cases per 100.000 inhabitants on 07/01 on 07.01.2021</i>).</p> <p>General information: A lockdown is in effect in Austria. The current measures will remain in effect at least until 7 February. Mass testing throughout Austria will take place before any rules are eased. People are required to stay at home at all times, and only leave the house for essential reasons, such as professional purposes, medical assistance or supervision.</p> <p>Non-essential shops are closed, and the requirement to stay at home will be in effect day and night (except for essential errands and purposes). Other shops must close by 19:00 and shoppers will be required to wear an FFP2 mask as of 25.01.2021.</p> <p>In all public places (indoors and outdoors), a minimum distance of 2 metres from each other must be kept. Events are cancelled (with some exceptions such as demonstrations and professional sports). People are asked to keep their social contacts to an absolute minimum. Private gatherings are restricted to no more than two households (6 adults, 6 children). Alcohol cannot be consumed within 50 metres of venues which sell alcohol. This includes petrol stations, bars and restaurants, as well as snack bars and kiosks.</p> <p>Cable cars in ski resorts have reopened on 24 December. However, due to entry restrictions and hotel closures, skiing is only possible for locals. When riding a cable car, anyone aged 14 or more should wear a FFP2 mask.</p> <p>A contact tracing tool Stopp Corona App is available.</p> <p>Hotels: Hotels are closed to tourists. Only essential travel (e.g. for business that cannot be delayed) is permitted.</p> <p>Bars and restaurants: Restaurants, bars and cafés are closed and only allowed to provide take away orders (between 6.00 and 19.00) or home delivery (24 hrs).</p>
<p>Azerbaijan</p> <p>Daily new confirmed COVID-19 cases</p> <p>Hotels in Azerbaijan: 0.00 average. The number of hotels in Azerbaijan is lower than the number of hotels in the world.</p>  <p>* 315 new cases recorded on 20.01.2021</p>	<p>Infection rate (cumulated past 14 days): 57.48 cases per 100.000 inhabitants (<i>down from 126.48 cases per 100.000 inhabitants on 07.01.2021</i>)</p> <p>General information: The period of the lockdown is extended until 31 January 2021. A strict lockdown was introduced from 14 December 2020 to 18 January 2021. The use of medical masks during this period in all indoor and outdoor areas is mandatory.</p> <p>Activity and rendering of services in all spheres are suspended, except for the scope of work and services determined upon the relevant resolution of the Cabinet of Ministers of Azerbaijan Republic</p> <p>Hotels are open. Guests can only leave premises with SMS authorization for essential movements.</p> <p>Bars and restaurants: are closed. All trade and catering facilities, including restaurants, cafes, and tea houses, are allowed to trade online or render delivery services to customers.</p>

Belgium

New daily cases (national)

The daily increase of the cumulative positive cases to the Coronavirus infection.

Infection rate (cumulated past 14 days): 133.38 cases per 100.000 inhabitants (*up from 117.68 cases per 100.000 inhabitants on 07.01.2021*).

General information: Lockdown measures in place until 15.01.2021. There is a nationwide curfew from 00:00 to 05:00. In Brussels and Wallonia there is a curfew from 22.00 to 06.00. Working from home is compulsory where possible

Gatherings in public spaces are limited to four people. At home, people can receive maximum one visitor from outside the household.

Non-essential shops and museums were allowed to reopen on 01.12.2020. It is prohibited to sell alcoholic beverages after 20.00. Nightshops must close at 22.00, and they will also have to stop selling alcoholic beverages after 20.00.

Hotels: Accommodations (hotels, B&B's etc.) may be opened, with the exception of their restaurants, bars and communal facilities (pool, fitness). Guests are only allowed to have meals in their room. Holiday parks (campsites, bungalow parks) are closed, with the exception of holiday residencies, bungalows, chalets, and camping equipment intended for use by the owner, or a household that has habitual residency there.

In Brussels, a [safety label](#) has been developed to reassure visitors that the site, venue or establishment in question is safe. The criteria for receiving such a label are based on checklists drawn up on the basis of specific protocols, developed in close cooperation with sectoral entities and representatives. Bars and restaurants: Restaurants, bars and cafés are closed. Take away meals and deliveries are permitted until 22.00. It is forbidden to sell alcoholic beverages after 20.00.


Bulgaria

New daily cases (national)

Infection rate (cumulated past 14 days): 118.61 cases per 100.000 inhabitants (*down from 150.08 cases per 100.000 inhabitants on 07.01.2021*)

General information: No curfew, but social distancing and restrictive measures are in place.

Non-essential shops are open, but visits to shopping centres and shopping malls are suspended until 31.01.2021. When serving customers directly, a distance of 1.5 metres and the use of a face mask/safety helmet are required.

The organization of congress and conference events, seminars, competitions, trainings, exhibitions and other public events is suspended. Cultural and entertainment are suspended. The only exception is represented by indoor theatre shows, that can be organized, provided that the seats are occupied up to 30% of their total capacity. Group celebrations of a private nature (including weddings, baptisms, etc.) are allowed with the presence of no more than 15 participants. The organization of excursions and group visits to tourist sites is suspended until 31.01.2021. Ski resorts are open subject to social distancing measures.

[Virusafe](#) is used to track and trace through a daily tracking for symptoms and health status with a voluntary GPS-based functionality.

Hotels are open. [Health protocols for tourism services and tourists](#) (in English)

Bars, restaurants and cafés: Catering establishments are temporarily closed until 31.01.2021. Only home and office delivery are allowed (no restrictions regarding opening hours/delivery times). An exception is in place for tourism accommodations, where catering establishments are allowed to function between 06:00 and 22:00, using 50% of their capacity.


Croatia

Infection rate (cumulated past 14 days): 276.19 cases per 100.000 inhabitants (*up from 167.24 cases per 100.000 inhabitants on 21.01.2021*)

General information: Restrictions on free movement in the country were lifted on 08.01.2021.

There are maximum 25 people allowed at public events. At private gatherings and ceremonies maximum 10 people can attend. Shops are open, but the general public health recommendations on physical distancing, personal hygiene and disinfection should be maintained. Cinemas, museums, theatres, professional artistic projections/exhibitions/performances are limited to 25 people. Establishments should close at 22.00. Public events can last until 20:00. There is a ban on the sale of alcohol from 22.00 to 06.00.

On July 2020 the government launched the [STOP COVID-19](#) app.

Hotels: Following the general public health recommendations on physical distancing, personal hygiene and disinfection, these services are open. For more details you can read the [recommendations for hotels and renters](#)

Bars and restaurants: Restaurants, bars and cafés are closed. Restaurants are allowed to prepare and deliver food compliant with all measures or personal collection, delivery, and drive-in services.

Cyprus

Infection rate (cumulated past 14 days): 512.73 cases per 100.000 inhabitants (*down from 768.85 cases per 100.000 inhabitants on 21.01.2021*)

General information: As of 10 January 2021, a strict lockdown is applied. A curfew is in place and the movement of citizens is banned from 21:00 to 5:00. Movement by exception will be permitted twice a day by sending a text message. Movement between Districts is subject to restrictions.

Facemasks required in outdoor public spaces. Social distancing measures of 2 meters outdoors and 3 meters indoors are in place. Gatherings in public and private places are prohibited. The presence in private homes of people other than permanent residents is prohibited, with limited exceptions

The operation of non-essential shops is suspended. All retail trade outlets may provide their services online or via telephone with house delivery.

Hotels: The operation of hotels or/and tourist accommodation units shall be permitted provided that they accommodate exclusively people who do not reside in the Republic, as well as for the accommodation of people in mandatory isolation. Catering areas inside hotels and tourist accommodation establishments may function until 21:00, serving only the guests staying in their premises, with a maximum number of people based on the available space and in general the following measures apply: the public shall exclusively be served at table arrangements; table reservations may not exceed 6 people; the maximum number of people allowed is 40 in indoor areas and 80 in outdoor areas, provided that a capacity of 1 person/3 square metres indoors and 1 person/2 square metres outdoors is maintained.

Bars and restaurants: The operation of catering establishments is suspended, with the exception of services concerned with home delivery and take-away (until 20:30). As of 21:00 only home delivery is allowed. Catering services at the Airports of Larnaka and Pafos are allowed to operate until 21:00.

Czech Republic

Infection rate (cumulated past 14 days): 1313.34 cases per 100.000 inhabitants (up from 1260.86 cases per 100.000 inhabitants on 07.07.2021)

General information: There are [5 alert levels](#) in the Czech anti-epidemic system. As of 27 December, Czechia has entered a higher restriction level: from level 4 to level 5 of the Counter Epidemic Score, corresponding to the highest level. An extended night curfew (between 21:00 and 04:59) is in place). In the time-slot between 05:00 and 20:59, it is anyway only possible to go out for basic needs (visiting friends or close parents, doing the shopping, travelling to work, etc.). The state of emergency will be in force until at least 22 January 2021.

The use of facemasks is mandatory in public spaces, including outdoors. Social distancing of 2 meters in all establishments. Social gatherings are allowed up to 2 people, both indoors and outdoors, with some exceptions, for example in the case of members of the same family. As of 27.12.2020, only 2 people are allowed to stay together in public places. The right of organizing a demonstration is allowed with the maximum presence of 100 people in clusters of 20, maintaining a distance of at least 2 meters between each cluster. All participants must wear a face mask or other kinds of respiratory protection devices.

As of 18.12.2020, only essential shops are allowed to be open, hosting 1 customer/15 square metres and a group formed by no more than 2 people (excluding children under 15 years old), ensuring the maintenance of a safety distance of 2 metres between them.

The operation of ski lifts and cable cars is prohibited and only the transport of goods and materials and the transport of people for other purposes is permitted.

Hotels: The operation of hotels and other accommodation services is limited. Accommodation services can be provided only for: business-related purposes; individuals who are required to stay in quarantine or self-isolation; foreigners before their departure from the Czech Republic; foreigners with valid work permit in the Czech Republic. Hotel restaurants can be open for guests between 5:00 and 20:59. During opening hours, guests must be seated, with a distance of at least 1.5 m between people of different tables. A maximum of 4 people can sit at the same table, if they are not members of the same household, while more than 4 people can sit at long tables. The total occupancy may not exceed 50% of the total restaurant. Find out more: [Accommodation facilities](#)

Bars and restaurants: Catering establishments are temporarily closed, but the takeaway option can be in function between 05:00 and 20:59, while home delivery is in function without time limits. Alcohol consumption at publicly accessible locations is prohibited. People who consume meals in the vicinity of the catering establishment, including beverages, are required to keep a distance of at least 2 metres from the others unless they are members of the same household. Denmark

New daily cases (national)

General information: A nationwide lockdown is in force and stricter measures have been applied to the whole country. A series of national measures will apply until the end of 28 February 2021 and even stricter measures are in place until 7 February 2021.

Masks are mandatory for over-12s in all closed spaces open to the public. General social distancing requirement of at least 2 meters. The Danish police can introduce a temporary ban on loitering if too many people are gathered in the same place.

Non-essential shops are open with strict health and hygiene requirements. A ban on small gatherings with more than 10 people is in place, with possible exceptions. A social bubble of no more than 10 people is recommended; large gatherings of more than 500 people are banned.

Shopping centres, department stores, shopping arcades and bazaars must stay closed. The same applies in case of durable goods shops, such as DIY stores and interior design shops, larger than 5000 squares metres. All shops which remain open are also required to have dedicated staff who are clearly responsible for the handling of COVID-19.

Recommended contact tracing app: smittestop.dk.

Hotels are allowed to remain open. It is normally prohibited to organise or attend events, activities etc. with more than five people at or in a hotel. However, if all the people attending an event etc. are members of the same household or each other's closest relatives, up to 10 people can attend simultaneously. Bars and restaurants: Establishments selling food, drinks or tobacco for on-site consumption must keep their premises and locations closed to the public until the end of 7 February 2021. However, restaurants, bars and similar establishments are allowed to stay open to the public during this period to sell food and drinks (except alcoholic drinks with an alcohol concentration of 1.2% or more from 10.00 pm to 5.00 am) not consumed on-site (takeaway or delivery) if they have the requisite licences under other relevant legislation. The same applies to restaurants etc. selling takeaway food or drinks and located in shopping centres, arcades or bazaars. Guidelines: [Nightclubs, bars, restaurants, and gambling arcades](#).


Estonia

New daily cases (national)

Infection rate (cumulated past 14 days): 603.18 cases per 100.000 inhabitants (*339.29 cases per 100.000 inhabitants on 07.01.2021*)

General information: No nationwide curfew. The government introduced stricter measures on 09.12.2020. From 14.12.2020, all educational institutions will be closed: general education schools, vocational educational institutions, institutions of professional higher education, and universities. Stricter measures are applicable for Harju County and Ida-Viru County from 28 December 2020 to 1 February 2021.

Shops are open. As of 16.11.2020, the 2+2 rule is in place in service halls and public areas of commercial enterprises, meaning that no more than two people may move together and at a distance of at least two metres. As of 28.11.2020, public events, such as performances, concerts, festivals, folk cultural events, fairs, conferences, etc. are allowed with a maximum number of 500 visitors outdoors or 400 visitors indoors with stationary seats (reduced at 250 if stationary seats are not available).

Hotels: Tourist accommodations are open to visitors, with precaution methods and processes in order to ensure people safety. Tourism accommodation services are closed in Ida-Viru County. Information published by the Health Board are available at: [Health protocols for tourism](#).

Bars and restaurants: As of 16.11.2020 restaurants, bars, cafés and all catering establishments in general are closed from midnight to 6:00, with the exception of takeaway. A 2-metres distance from other people must be observed and disinfectants must be made available for clients, in order to apply hygiene measures. A nationwide restriction on the sale of alcohol is in place. According to this, late-night alcohol sales is forbidden from midnight to 10:00 in all points of sale where alcohol is sold for consumption on the spot, for example, bars, nightclubs, restaurants, theatre buffets and hotels.

In Harju County and Ida-Viru, catering establishments are closed but can provide takeaway and delivery services.


Finland

General information: No curfew or restrictions on free movement.

The use of masks in public transportation and among the public in areas that experienced covid-19 cases within the last 14 days is recommended. Maintaining physical distance of 1-2 metres is recommended. Non-essential shops are open with the following safety measures: limitation of the number of visitors, physical distancing and guidance on personal hygiene. The restrictions and recommendations concerning events, gatherings and meetings [differ from one region to another depending on the phase](#) of the epidemic (stable phase, acceleration phase, or community transmission). The guidelines on good hygiene and safe distances are in force at all phases.

Hotels are open but many are forced to keep their services closed due to lack of customers as well as financial reasons.

Bars and restaurants: In restaurants throughout Finland customers must have their own seat. All food and beverage service establishments may be open until midnight at the latest. Restaurants may allow three quarters of the normal number of customers in the premises at a time. In the provinces that currently see the largest increases in contagions, namely Uusimaa, Southwest Finland, Pirkanmaa, Kanta-Häme, and Ostrobothnia, establishments must stop serving alcoholic beverages by 22.00 and close at 23:00.

In the other regions, establishments must stop serving alcoholic beverages by midnight, and food and beverage service establishments may be open round the clock. There are no restrictions on the number of customers. Establishments that primarily serve alcoholic beverages must close by 01.00.


France

General information: France has entered a new national lockdown since 30 October. A nightly curfew is currently in force in metropolitan France. Between 18:00 and 6:00 you may leave your residence only for essential reasons and with an exemption certificate.

A physical distancing of at least 1 metre applies in all places and circumstances. Mass gatherings with more than 6 people are prohibited. Exceptions apply in case of professional meetings, transport services, funerals (within the limit of 30 people). Social gatherings are banned.



As of 15 December 2020, shops (including bookstores, record stores and libraries) are allowed to be open until 18:00 (depending on the department concerned), in compliance with a [reinforced sanitary protocol](#). To limit the concentration of flows and promote commercial activity, the possibilities of opening shops on Sundays are widened. However, cultural venues such as museums and higher education establishments must remain closed.

Ski lifts and public facilities are currently closed and the epidemic circulation does not allow to consider the reopening before February.

Health protocols for tourism services and tourists. [TousAntiCovid](#) is available since 2/6/2020. The App allows the user to be notified of possible close contact (less than 1 metre for at least 15 minutes) with someone who has then been tested positive to Covid. "

Hotels can remain open but must close their catering facilities, room-service only.

Bars and restaurants are likely to remain closed until at least 6 April 2021 ([unconfirmed at time of writing](#)). Delivery is authorised around the clock; take-away services possible until 18:00.

<p style="text-align: center;">Georgia</p>  <p style="text-align: center;">* 954 new cases recorded on 20.01.2021</p>	<p>Infection rate (cumulated past 14 days): 402.46 cases per 100.000 inhabitants (<i>down from 467.46 cases per 100.000 inhabitants on 07.01.2021</i>)</p> <p>General information: Effective November 28, the Government of Georgia imposed new measures in an effort to curtail the COVID-19 pandemic. For the period until 31.01.2021, countrywide restrictions include: between the hours of 21:00 and 05:00, public and private transportation, including walking, is not permitted, unless it is for an essential need (for example, medical services).</p> <p>Face masks are mandatory in all closed spaces. No more than 10 people can participate in social gatherings, indoor or out. In Tbilisi and 7 other cities, all shops except grocery stores, pharmacies, banks, vehicle repair and beauty salons will operate in on-line delivery mode only, except on weekdays only from 16 to 31 January. Working from home is recommended where possible. Ski resorts will remain closed until at least February.</p> <p>Hotels, bars and restaurants: Some hotels and other rental accommodation remain open but many are closed. Restaurants and eateries may provide delivery, take-away, and drive-thru service only.</p>

(source: JRC ECML)</p>  <p style="text-align: center;">(01-03-2020 - 19-01-2021)</p>	<p>Infection rate (cumulated past 14 days): 318.74 cases per 100.000 inhabitants (<i>up from 298.63 cases per 100.000 inhabitants on 07.01.23021</i>)</p> <p>General information: On 19.01.2021, the application of strict measures was prolonged by the government until at least 14.02.2021. All citizens are urged to refrain from non-essential travel within Germany and abroad. States are to limit the movement radius of residents to 15 kilometers around their homes (for non-essential purposes), for counties that have registered more than 200 infections per 100 000 people within seven days. Specific regulations for each federal state are available at the Federal Tourism Competence Centre.</p> <p>‘Medical grade’ facemasks should be used in public closed spaces, as well as masks outside shops where queues are formed and in car parks. Personal contacts between households must be restricted to an “absolute minimum”. Personal contacts are to remain limited to a maximum of 5 persons from 2 households. In public, household members can gather with only one person from another household (excluding children until 14 years of age). The government is also upping pressure on employers to enable remote working. Each federal state can set specific rules for the maximum number of people that are allowed to meet together, with different limits applicable to indoor and outdoor spaces.</p> <p>Retail stores, with the exception of grocery stores and shops to meet daily needs, are to remain closed.</p> <p>Recommended contact tracing app: Corona-Warn-App</p> <p>Hotels: Hotel stays for touristic purposes are prohibited. Details on the current restrictions in the federal states are available on the tourism guide.</p> <p>Bars and restaurants: Restaurants, bars and cafés are closed (except for delivery and take-away). Details on the current restrictions in the federal states are available on the tourism guide. Regional restrictions on authorised hours for alcohol sales are commonplace.</p>


Greece

General information: The Greek government has announced strict lockdown starting on 03.01.2021. A decision to apply the measures 'indefinitely' was taken by government on 15.01.2021. Citizens in need of going out for essential reasons will have to notify it and to provide specific certificates (type A and type B) according to the reasons of their movement and receive authorisation by SMS. From 21:00 to 05:00, a curfew is in place, together with a ban on traveling outside home prefectures. Consequently, only essential movement is allowed (work, health, pet care). Due to the increased epidemiological burden in the wider region of West Attica and specifically in the Municipalities of Aspropyrgos, Elefsina and Mausoleum, the Greek Government announced the tightening of the current lockdown, with a curfew from 18:00 to 05:00 in place.

The use of facemasks is mandatory both indoors and outdoors. Gatherings with 4 or more people are not allowed. Individual sport with a maximum number of three people is allowed. Special social distancing rules have been set for a wide range of places. Retail shops were allowed to reopen on 18.01.2021 with strict capacity limits.

Hotels: Tourism accommodations remain open under specific hygiene protocols.

Bars and restaurants are temporarily closed. However, home delivery and takeaway services are available also between 21:00 and 05:00, within the permitted movements during these hours.


General information: As of 11.11.2020, a curfew is in place from 20:00 to 5:00 and only essential movements are allowed within a 500 metre radius. Bars and restaurants: Restaurants, bars and cafés are closed, but pick up/delivery is permitted. The ban does not apply to catering activities in accommodation where catering activities may be carried out between 06.00 and 22.30, but only to guests staying in accommodation establishments.



General information: National curfew between 23.00 and 06.00 in place, Canary islands excluded. Autonomous regions have the authority to start the curfew an hour earlier, or later. Further regional and local restrictions can apply. There are several municipalities or regions that are subject to a perimetral lockdown, meaning residents cannot leave or enter the area unless it is for essential reasons, such as for work, to access care services or in the case of an emergency. Also, many municipalities without entry and exit restrictions have introduced other types of measures, such as a reduced capacity for restaurants, bars and cafés. Shops are open; special attention is required in commercial areas and street markets. Restrictions can differ between autonomous regions.

Face masks are mandatory in public spaces, indoors and outdoors. Most regions in Spain have made masks obligatory outdoors as well. Outdoor social gatherings are limited to 6 people. Physical distancing measures must be guaranteed and the maximum precautions must be taken to avoid meetings and overcrowding in indoor places.

The contact tracing app [Radar Covid](#) is currently being rolled out in regions across Spain after a pilot test in La Gomera.



Hotels: are open, but occupancy is often limited, and there can be restrictions on valet parking and ironing services. In-house catering services have to comply with the general disinfection and social distancing measures, as well as restricted opening hours. There may be temporary limitations on the number of guests per table. Measures may be changed when necessary to respond to the local COVID-19 situation.

Bars and restaurants: Many restaurants, bars and cafés have limited opening hours. Depending on the local situation, services can be cancelled completely, except for home delivery and take-away. For restaurants, in general, a maximum of 10 guests is allowed per table. Booking in advance is recommended. Stricter limits may be enforced as necessary. It is forbidden to smoke in the open air when a safety distance of 2 metres cannot be maintained.

Schools for over-16s will continue online classes until 24.10.2021. Employers are asked to let non-essential staff work from home until 24.01.2021.</p> <p>Crowding must be avoided. People are asked to refrain from traveling as much as possible. Public gatherings and events may have a maximum of 8 participants. There is no general requirement to wear a face mask in normal social situations, in public places, and in public transport, but their use is highly recommended since 07.01.2021. Turkey

Infection rate (cumulated past 14 days): 144.99 cases per 100.000 inhabitants (*down from 231.67 cases per 100.000 inhabitants on 07.01.2021*)

General information: Turkey previously tightened COVID-19 measures Dec. 1. Authorities have imposed a 2100-0500 curfew nationwide on weekdays; a weekend curfew is in effect from 2100 each Friday until 0500 the following Monday. Foreigners in the country temporarily for tourism are exempt from curfews and travel permit requirements.


While most nonessential stores and businesses must close, grocery stores and food delivery services are exempt from the weekend curfew.

A range of measures remains in force outside curfew hours. All persons nationwide must wear protective facemasks and observe social distancing while in public. Strict social distancing guidelines have also been imposed on public transport.

Hotels are open. Restaurants in hotels/accommodation facilities will be open; however, they will be available for hotel guests only.

Bars and restaurants: Dining establishments such as restaurants, patisseries, cafes, and cafeterias are closed for in-person dining and may offer delivery services between 10 a.m. and 8 p.m.

United Kingdom

Infection rate (cumulated past 14 days): 987.73 cases per 100.000 inhabitants (*down from 1035.42 cases per 100.000 inhabitants on 07.01.2021*)

General information: the four home nations (England, Scotland, Wales and N. Ireland) apply measures differently. All four home nations are currently under strict lockdown rules, expected to last until late March in England and mid-February in Scotland. Wales has been in a national lockdown since 20 December, and will only consider reviewing rules at the end of January. Measures in Northern Ireland will apply until 06.02.2021.

People in **England** must stay at home and only go out for essential reasons. Only essential shops are open. Schools are closed. Indoor and outdoor household gatherings are prohibited. 2 meter social distancing rule.

In **Scotland**, there is a five-tier system (from zero to four). On 04.01.2021, mainland Scotland (and the isles of Skye, Arran, Bute and Gigha) moved to "enhanced level four" until at least the end of the month. Orkney, Shetland, the Western Isles and other island communities remained in level three. People should not travel outside their own local authority area for anything other than "essential" reasons. It is illegal to travel between Scotland and other parts of the UK unless the journey is essential. A maximum of two people from up to two households can meet outdoors.

Wales is under a strict level 4 lockdown, with only essential movement authorised. **People**. must not visit other households and are asked to work from home. Non-essential shops are closed. **Northern Ireland** follows similar rules.

Hotels: Strict hygiene and safety measures apply. Shared facilities should not be open.

Bars, pubs, cafés and restaurants: are closed in all 4 home nations (except in a few level 3 areas in Scotland which can open until 18:00, but where no alcohol can be sold) and only takeaway and delivery are authorized. Takeaway alcohol is banned in England. [More info](#).




Figure 1 : Combined indicator: 14-day notification rate, testing rate and test positivity, updated 21 January 2021.
